"Who?" Rupert asked, furrowing his eyebrows tightly.


Annabel cracked a faint smile. "Who has the most to gain if the Ice and Fire collection is ruined?"


Rupert slightly leaned back in his chair and mused, "Indeed. It's very likely that Love Jewelry is behind this matter."
