Surely, such a live stream entrance cover would attract plenty of attention.


After all, they were the super popular legal anchor, Professor Luo Xiang, and the super popular robot, Big White!


What kind of sparks would fly when the two collided?

After all, Professor Luo Xiang was already a professor at Xia Country Political and Law University and would rarely have time to teach law students at Mist City Arts and Science University.


But holding an honorary professorship was no problem, right?
