Now that he felt he was in a good position, he declared arrogantly, "Prepare yourself very well! Tomorrow, you won't be able to smile anymore!"




Cayson's face stiffened, his embarrassment quite obvious. His fists were clenched under the table as he struggled to control himself.



She never really tried to keep it secret though, since the company's construction team was the one she used in the project.


But the shareholders had known nothing about it, and now, they were looking to her for answers. "Miss Torres, is this true?" one of them asked her.
