She struggled to explain the uncertainty of the situation, but aunt Susan and Ross accused Rhonda of trying to embezzle the money, which infuriated her.


On the day Rhonda was about to leave work, Eliam called her, demanding to know why she wanted to sue his grandfather.


"Those wealthy people really do whatever it takes to make money."


Rhonda remained silent upon hearing this.
