Rhonda recalled hearing that a man in the northern district spent his days loafing around, yet managed to secure the highest monthly bonus due to his questionable relationship with Tamara.


She couldn't be certain if Roderick was that man.


However, it stood to reason that if Roderick was indeed that individual, he wouldn't be targeting Tamara.
