She didn't know whether to hate Santino or feel sorry for him. Regardless, both Santino and Cristina were now out of her life.


"You're seriously unlucky. Why did they assign Cristina to our team? Having to face her every day will be unbearable," Fiona complained as soon as they were in the car.


"And I can't understand why our company placed her and Paget in the Sloan project team. Doesn't that just create more chaos? Isn't it incredibly unfair?"
