Damon, taken aback by her directness, quickly shook his head and proceeded to explain his recent interactions with Wray, hoping to clarify his stance.


Loraine was well aware of Damon's past actions, so she was skeptical of his claim that he had no involvement. She doubted his sincerity and believed he was likely lying.
